Nominations are considered to be made by those who sign the form, even if representing a group of members. **At least three of the five nominators must be professional engineers registered in good standing with Professional Engineers Ontario (PEO).** The first-signed nominator will be considered the sponsor and will be the contact with the Awards Committee.

Information about the project or achievement's Principal Engineer is required. The Principal Engineer may also serve as a sponsor or nominator for the project or achievement. **Note:** only the Principal Engineer will be invited to the awards gala as a guest of the Ontario Professional Engineers Awards to receive the award.

The Ontario Professional Engineers Awards are presented annually. **The nomination deadline is 4:00 p.m. EST on the last Wednesday in February;** however, nominations may be submitted any time during the year. Nominations submitted after the deadline may be considered, with or without changes, before the deadline for the following year's program at the request of the lead nominator.

Completed nomination packages, excluding the nomination form, **cannot exceed 20 pages.** The nomination package page count will start with "Project Description" on page 5 and includes all supporting documentation, such as letters of support, resumes, media clippings, etc.

Project complexity (20 points)

How complex was the project or achievement and or the problems overcome by the team of engineers? How cost effective were the solutions to overcome the problems? Can the solutions be applied to future projects to overcome problems?

Environmental impacts (20 points)

Was the project or achievement realized in a manner that promoted sustainable development? Were the environmental impacts of the project or achievement minimized?

Client expectations (10 points)

How closely did the project or achievement meet client expectations? Was the project or achievement completed on time and on budget?

Letters of Support from Nominators

A letter of support from **each of the five** nominators is required to provide additional information on the project or achievement as part of the nomination package. The letters of support will be included in the page count.
