COUNCIL APPROVES RECOMMENDATIONS TO MOVE FORWARD ON DOWNSWIEW INQUIRY



PEO Council meeting on September 19.

PEO held a Council meeting on September 19 and 20 at PEO headquarters.

The meeting was chaired by PEO President Nancy Hill, P.Eng.

PEO Legal Counsel **Dan Abrahams** presented an activity filter designed to categorize PEO's activities.

The meeting approved 2020 operating and capital budgets.

Council decided not to proceed with creating a specialist designation for professional engineers designing and inspecting demountable event structures.

But Council did approve a proposal to require annual reporting by all licensed engineering practitioners regarding their current practice status, area of engineering practice, and other relevant information.

The motion also directed the CEO/ Registrar, **Johnny Zuccon**, P.Eng., to amend the *Professional Engineers Act* to take other actions to make this possible.

This was one of the recommendations coming out of the Corner's inquest examining the death of Scott Johnson in the Downsview Park stage collapse.


TOMORROW IS THE EASTERN REGION GLP ACADEMY AND CONGRESS
