NEW GLC MEMBER SHARES HER INSIGHT ON THE GLP

Below is a June 2nd interview with PEO Brantford Chapter Chair **Vicki Hilborn**, P.Eng. She is the newly appointed Government Liaison Committee representative for the Advisory Committee on Volunteers.


1. What is your experience dealing with the political process?

Before my involvement with the GLP, I was only an observer and voter in the political process. I have always been interested in getting more involved in the process, because I understand that our elected officials have a major impact on our day to day lives.

GLP provided me with an opportunity to both understand the process, ask the simple questions and better understand the effective ways to interact with my local MPP. Since my involvement with the GLP, I have connected with my local MPP for activities related to both PEO and other local events.

I have found that these interactions help me promote the role of the engineering regulator within my community.

2. Why did you get interested in government liaison activities at PEO?



PEO Brantford Chapter Chair Vicki Hilborn, P.Eng., is the newest appointment to the Government Liaison Committee (GLC).

As a public servant, I have seen the impact (positive and negative) of government on Ontario's citizens and understand the importance of ensuring that PEO maintains a strong and supportive relationship with its government partners. I see the GLP as having a strong role in building and maintaining these relationships—particularly with MPPs outside the GTA.

I also saw an opportunity to better understand the motivators for PEO volunteers involved in the GLP. Volunteers tend to be younger and from across Ontario, as compared to other volunteer roles within PEO. As Chapter Chair, I have found this segment of PEO's membership hard to reach, and I hope to learn more about activities which may encourage them to be more involved in their local Chapter.

3. What do you think the biggest challenges are for the GLP?

GLP is challenged to determine its role as PEO continues to refocus on its regulatory role. GLP needs to compare its role to groups in other regulatory bodies and determine how other bodies balance the need for MPP relationships and the need to focus on a core regulatory role.

GLP also needs to be willing to question how its current activities fit within the regulatory role and be able to articulate their value.

4. What do you think the biggest opportunities are for the GLP?

GLP allows an opportunity for PEO to build stronger relationships with our government partners. It also provides new opportunities for volunteers who want to support their local community and better understand the role of politics in their everyday life.
