They want to strike all sections of the legislation that refers to the Consulting Engineer designation. This matter is currently with Council.
- Changes to the Fair Access To Regulated Professions and Controlled Trades Act. Seeks to remove 12-month Canadian experience requirement to assist newly arrived engineers to find employment.
