MPP Vanthof was elected as a member of the New Democratic Party to the Ontario Legislature in 2011. He is one of two NDP Deputy Leaders and is the Critic for Rural Development, Agriculture and Food.

Prior to his election, he was a full-time dairy farmer and had served on the Temiskaming Dairy Producer Committee, the Board of Dairy Farmers of Ontario and as President of the Temiskaming Federation of Agriculture.

He was also a keynote speaker at both PEO's Northern Region GLP Academies and Congresses in North Bay in 2019 and in Sudbury in 2012.
