1.0 Call to order and welcome

The Chair, L. MacCumber, welcomed everyone and called the meeting to order at 6:02 p.m.

2.0 Routine Business

2.1 Approval of the Meeting Agenda

3.0 Chapter Issues

3.1 Open Issues

Open Issue #135 – ERC moves that whereas PEO HQ has adopted a centralized banking system in 2019 that is fully administered under the PEO CFO such that Chapters no longer manage accounts, process payments or issue payments; whereas financial reporting to Chapters is in the form of a summary that contains deductions from Chapter accounts outside Chapter Business Plan activity; whereas PEO HQ receives claims, processes claims, makes payment directly to individuals/companies/providers, records payments, and provides monthly statements; that the position and past by-law role of Treasurer should be removed from Chapter constitutions/by-laws as it is redundant and causes double tabulation and reporting with inherent errors; that this issue will be deferred until such time that Council has confirmed the role of chapters with regard to the future of PEO.

RCC Update: Motion brought to RCC's attention. Because it is a postponed motion there is no action required at this time.

Open Issue #46 – The Northern Region moves to request RCC acquire clarification from Council on criteria for eligible PEAK courses as an important area of non-technical knowledge appears to have been missed, which has a direct impact on worker safety, such as OHSA regulations.

RCC Update: Recommend to close and instead the Northern Congress should make a Motion to Refer the concerns raised in Open Issue #46 to the Regulatory Policy & Legislation Committee (RLPC) as they will be reviewing CPD issues for the new mandatory program.

Open Issue 82 - WRC moves that PEO will provide regular and public updates (separate from the Registrar's Report) on the progress of applicant files with both the Academic Review and the Experience Review Committees.

4.0 Chapter & RCC Finances

4.1 2022 Proposed Budget

A. Ribeiro presented the proposed budget for the 2022 Chapter Operations, noting that the chapter allotment figure is not yet known because the business plans are due on July 31. The RCC agreed to approve the budget as presented.

5.0 RCC Issues/Chapter Policies/Documentations/Processes

5.1 Volunteer Leaders Conference Planning Committee Representative

L. Roberge explained that the Volunteer Leadership Conference Planning Committee (VLCPC) requires two members from RCC. He is filling one of those roles however the other representative is no longer a member of RCC. He briefly explained the VLC event and requested another member of RCC volunteer as the 2nd representative. The role is a 1-yr term but for succession purposes, the members of the committee often stay for longer. He noted staff have been very supportive of the committee.

Jim Chisholm, Junior Councillor for the West Central Region volunteered. RCC agrees that J. Chisholm will be the 2nd RCC representative on the VLCPC.

6.0 RCC Subcommittees/Task Forces/Working Groups updates

6.1 2021 Chapter Leader Conference Chair and Vice-Chair

A Ribeiro explained that the Chapter Leaders Conference is led by two representatives from the RCC, on alternating 2-yr terms. Councillor C. Chiddle is moving from the Vice-Chair to the Chair position and is looking for another representative from RCC to join as Vice-Chair for the 2022 CLC.

Christopher Chahine, Junior Councillor for the East Central Region volunteered. RCC agrees that C. Chahine will be the 2022 CLC Vice-Chair.

7.0 Other Business

J. Chisholm shared recent event news with the committee. On May 11, the West Toronto chapter partnered with the Society of Fire Protection Engineers-Southern Ontario Chapter (SFPE-SOC) with a full-day symposium. It was a very successful event with 160 participants. Next year it will be held on May 10, 2022, the SFPE-SOC is looking for PEO chapters to co-sponsor the event. He asked the RCC to share this information with their chapters and any interested chapters can contact J. Chisholm for further information.
