

PEO PRESIDENT SPEAKS AT WEBINAR FOR EIGHT CHAPTERS ON PEO VISION



WATERLOO - PEO President **Roydon Fraser**, P.Eng., was the guest speaker on the special webinar put on by eight chapters on September 26. The webinar was part of the "Developing Engineering Leaders" seminar series.

Mr. Fraser spoke at length about PEO's role as a regulator, and how PEO can enhance its responsibilities. He specifically discussed what PEO's future responsibilities might look like as emerging industries will begin to become more prominent.
