Mississauga Mayor **Bonnie Crombie** is the new Leader of the Ontario Liberal Party.

"Mayor Crombie is frequently invited to attend events all over Mississauga and has on many occasions, participated in PEO Mississauga Chapter activities with our MPPs," said PEO Mississauga Chapter GLP Chair **Jeannette Chau**, P.Eng. "As a result of the Chapter's work, she is very familiar with PEO's regulatory mandate."

PEO ISSUES STATEMENT ON USE OF FABRICATED PROFESSIONAL ENGINEER'S SEAL

TORONTO, Nov. 28, 2023 - The Ontario Court of Justice at Kitchener fined a New Brunswick man, **Jay Lawrence Harding**, \$50,000 for using a fabricated professional engineer's seal in the course of performing "inspections" and "non-destructive tests" of cranes, lifting devices and related parts.

Between 2019 and 2021, Mr. Harding, operating through a sole proprietorship (AJ Ontario Hoist Inspections), used a fabricated seal bearing Harding's name and the title "licensed professional engineer" in the course of performing a large number of "inspections" and "non-destructive tests" of cranes, lifting devices and related parts in several municipalities across Southwestern Ontario.

On November 22, 2023, Mr. Harding pled guilty to 27 counts of breaching section 40(2)(c) of the *Professional Engineers Act* in connection with this conduct. Her Worship **Michele Thompson** imposed a \$50,000 fine on Mr. Harding.

Additionally, on August 29, 2023, the Honourable Justice **Michael Gibson** of the Ontario Superior Court of Justice at Kitchener issued a permanent statutory injunction under section 39 of the *Professional Engineers Act* prohibiting Mr. Harding from holding himself out as a professional engineer or using an engineering seal in Ontario in the future.

Matthew Howe and **Jeffrey Wang**, both from the Toronto law firm Polley Faith LLP, represented PEO on the matter.

PEO reminds the public that the unauthorized use or forgery of a professional engineer's seal on construction or design drawings is a quasi-criminal offence under the *Professional Engineers Act*. Such conduct may also result in criminal charges under the Criminal Code of Canada.

Professional Engineers Ontario administers the *Professional Engineers Act* to serve and protect the public interest by licensing Ontario's 85,000 individual practitioners and engineering firms. Professional engineers can be identified by the P.Eng. after their names. When retaining the services of an engineer or engineering firm, the public may search the directories of licensed professional engineers and authorized professional engineering companies at https://peo.on.ca/directory. PEO COUNCIL AND CEO/REGISTRAR COMMEMORATE MEMORIES OF DECEMBER 6TH VICTIMS

Members of the PEO leadership team commemorated the anniversary of the December 6th, 1989 shooting at École Polytechnique in Montreal. Tributes included a moment of silence at the 560th Council meeting on November 16th, as well as statements released by PEO CEO/Registrar Jennifer Quaglietta, P.Eng. "Twelve of the victims were engineering students across many disciplines--mechanical, civil, chemical, materials," said Ms. Quaglietta in a LinkedIn post. "Their lives were cut short by a misogynist who couldn't bear to see women studying engineering - a supposedly 'male profession.'

"Over the last many years, this reflection has led to significant efforts by the engineering profession to look inward, to be honest about the gender bias that exists, and then to take steps towards removing barriers that women engineers, and women wishing to become engineers, experience."
