Why am I running for President Elect?

I am proud to be a Professional Engineer in the Province of Ontario and of having volunteered with the PEO for over 20 years. There are however issues that I am concerned about and want to address:

I want to ensure that the recent changes to PEOs operating structure works for everyone.

PEO's council has recently completed a major restructuring of how it operates. The conclusion of which I would have expected there to be an opportunity for the membership to provide feedback on how these changes are affecting them, to ensure that the new structures are working for everyone. Since having left council at the completion of my last term as regional councillor however I have seen no such communication. I want to correct this.

2. I want to address PEO's licencing practice under FARPACTA When the province passed FARPACTA, PEO complied by essentially cutting out new applicants loose and making it necessary for them to have everything in place before applying. This, I feel has been a huge disservice to, not only the applications, but to the existing membership and the profession as a whole. Although this new approach makes the processing of licence application much easier it does nothing to make access to the P.Enc. licence better but does introduce potential

unintended consequences that have vet to surface. I want to address

this to ensure that integrity of the profession remains unaffected and

make the qualification process easier for all.

3. I want to improve our issues with member engagement.

Member engagement at PEO has always been a problem. If you look at the statistics posted on the PEO website for the last five years you will see that we haven't done better than 15% of eligible members voting. You will also see that these numbers are still in a steady decline. As I see it, there are only two reasons for this. Either 1; the membership doesn't feel that their vote means anything or; 2: the membership generally doesn't care. Both of these answers should be equally concerning. I want to start a dialog with out members in a series of town
