ASSOCIATE MINISTER OF TRANSPORTATION SPEAKS AT PEO WEST CENTRAL SYMPOSIUM

MISSISSAUGA - Over 300 professional engineers and others participated in the PEO West Central Symposium, *Engineering Today for Tomorrow* on February 24 at The Trinity Hall Canadian Coptic Centre in Mississauga.

Vijay Thanigasalam, MPP (Scarborough - Rouge Park), Associate Minister of Transportation spoke at length about the province's transportation initiatives and PEO's important role as the regulator of professional engineering in Ontario. Also in attendance was Sheref Sabawy, MPP (Mississauga - Erin Mills), Parliamentary Assistant to the Minister of Public and Business Service Delivery.

PEO PRESIDENT-ELECT MEETS PREMIER AT COMMUNITY EVENT HOSTED BY MPP



PEO President-Elect **Gregory Wowchuk**, P.Eng., spoke with Ontario Premier **Doug Ford**, MPP (Etobicoke North), and **Christine Hogarth**, MPP (Etobicoke - Lakeshore), Parliamentary Assistant to the Solicitor General, at an event in Etobicoke on February 13.

PEO President-Elect **Gregory Wowchuk**, P.Eng., had the opportunity to meet Ontario Premier **Doug Ford**, MPP (Etobicoke North) at a community event on February 13.

Mr. Wowchuk told the PEO *GLP Weekly Times* that he had the opportunity to speak with the Premier and reminded him that "the engineering labour market has a large regulatory component as high-level engineering jobs and good salaries are necessary to promote quality engineering work."

He also had the opportunity to speak with his MPP **Christine Hogarth**, MPP (Etobicoke - Lakeshore), Parliamentary Assistant to the Solicitor General, who hosted the event.

The PEO Government Liaison Program aims to engage MPPs in various ways to inform them of the initiatives being undertaken in support of PEO's regulatory mandate, which should align with the government's expectations of a regulatory body acting in the public interest.

Mr. Wowchuk will assume office as PEO President at the PEO Annual General Meeting in Barrie on April 20.

PEO HOLDS 561ST COUNCIL MEETING

PEO held its 561st council meeting on February 23 at PEO Headquarters in Toronto. It was chaired by PEO President **Roydon Fraser**, P.Eng.

Council had a busy agenda, including reports from President Fraser and PEO CEO/Registrar **Jennifer Quaglietta**, P.Eng. For a full copy of her report, see <u>here</u>.

Additionally, Council nominated former PEO President **Marisa Sterling**, P.Eng., and longtime PEO Councillor **Arjan Arenja**, P.Eng., to serve as PEO Directors to the Engineers Canada Board of Directors, each for a three-year term effective as of the 2024 Engineers Canada Annual General Meeting.

Council also made the decision to appoint a Northern Regional Councillor at its April 2024 meeting to fill the current vacancy.

Additionally, Council also approved:

- The three-step plan proposed by staff regarding governance controls for director conduct
- The proposed risk management policy as presented to the meeting
- The 2024 Annual General Meeting: Guide for Member Submissions
- The CEO/Registrar 2024 Goals Review Form

PEO Council also directed the Regulatory Policy and Legislation Committee (RPLC) to add "Emerging Disciplines" to their 2024-2025 Work Plan. They also referred the Safe Disclosure (Whistle-blower) Policy to the Governance and Nominating Committee to consider possible improvements to the policy and report back with recommendations, if any, by the end of 2024.
