MPP Flack also serves as the Minister of Agriculture, Food, and Agribusiness. He was first elected in 2022 and this was his first opportunity to meet with PEO representatives.

House Leader Clark regularly participates in PEO Thousand Island Chapter events and was the guest speaker at two PEO GLP training summits. He also participated in an independent GLP audit which interviewed PEO Councillors, Chapter reps, and over 10 MPPs.

The PEO delegation had the opportunity to review PEO's work with the *Fair Access to Regulated Professions and Compulsory Trades Act* and its impact on licensing. Ms. Bergeron and Mr. Houze also briefed the MPPs on local chapter activities and discussed the possibility of Premier **Doug Ford**, MPP (Etobicoke North), attending a future PEO event.

PEO KINGSTON CHAPTER MEETS WITH LOCAL MPP FOR FIRST TIME

SMITH FALLS - The PEO Kingston Chapter had a productive meeting with **John Jordan**, MPP (Lanark—Frontenac—Kingston) at his Smith Falls office on August 13. Participants of the meeting included Kingston Chapter's Chair **Susan Shi**, P.Eng., GLP Chair **Hafiz Bashir**, P.Eng., and GLP rep **Sevda Salimi**, EIT, who organized the meeting.

They discussed the role of PEO and other engineering organizations in Ontario and emphasized PEO's responsibility as the regulator of the profession in the public interest. The delegation briefed MPP Jordan on how PEO revised its licensing process to comply with the requirements of FARPACTA, including removing the 12-month Canadian work experience requirement.

MPP Jordan was also invited to the Chapter's New Licence Ceremony and Golf Tournament on October 2, their AGM in February 2025, and a planned PEO 'Take Your MPP to Work Day' in 2025, all of which the MPP expressed interest in attending.

MPP Jordan was first elected in the June 2022 provincial election and currently serves as the Parliamentary Assistant to the Minister of Agriculture, Food, and Agribusiness. This was the Chapter's first meeting with MPP Jordan.

Mr. Bashir served as one of only two Chapter reps on the PEO Government Liaison Committee.

CO-CHAIRS FOR UPCOMING ANNUAL LIBERAL CONFERENCE ANNOUNCED


