Nomination Form for Honorary Membership

The Order of Honour is PEO’s highest volunteer recognition program which identifies PEO volunteers who have made a substantial contribution to support PEO’s statutory mandate to regulate the engineering profession in Ontario to protect the public interest.

Honorary inclusion in the Order of a non-member of PEO can be considered, for volunteering for PEO regulatory activities for many years. A non-member of PEO may be granted honorary inclusion in the Order, in any class, for outstanding service, support or assistance to the engineering profession in Ontario. Such service will primarily be rendered through participation in PEO affairs. Service performed in other engineering organizations or agencies may be considered but only as complementary to PEO service. Nominations are considered by PEO’s Order of Honour Selection Committee, which will assess the nominations and make its recommendations to PEO Council. The committee may also conduct its own research and make independent selections and recommendations for inclusion in the Order. All nominations received will be considered on an equal basis.

All three nominators must be professional engineers and members of Professional Engineers Ontario, in good standing. Nominators should supply complete detail on their nominee. Individual statements from each nominator on the reasons the candidate should be considered for this award must accompany the nomination.

Induction into the Order of Honour is a competitive process. Therefore, nominators’ letters should highlight not only the years of service, but also the substantial contribution and impact candidates have made on the engineering profession. 1. Please note that induction into the Order of Honour is a competitive process. A maximum of 13 honorees are inducted annually. Therefore, nomination packages need to highlight the significance and impact of the nominee's contributions to the engineering profession.
2. List all PEO service activities and include dates of such service. Include the names of committees served or special functions performed on behalf of PEO.
3. If the nomination is being made for a specific contribution or contributions, supply full details of the activity or activities and why it or they should be recognized.
4. Individual statements from each nominator on why the nominee should be considered must accompany the nomination. Please note that the nomination reference letters are the most significant component of the nomination packages and should be written by those who can substantiate the significance of the nominee's contributions to the engineering profession, primarily as a PEO volunteer. External volunteer service is also a contributing factor and details of service rendered through other engineering bodies, or PEO external appointments, should be included in the reference letters.

6. Materials that support the nomination, such as clippings, testimonials, or letters of support, may be included.
7. Nomination packages **should not exceed 15 pages**, excluding the nomination form. Any pages beyond 15 will not be considered in the selection process. **All materials must be submitted by e-mail at: orderofhonour@peo.on.ca.**
8. The deadline for receipt of nominations is **4:00 p.m. Eastern Standard Time** on the **second Friday in October**. Nominations submitted after the deadline will not be considered for that year's awards program, but may be reconsidered at the discretion of the committee before the deadline for the following year's program.
