For redesignation as a Consulting Engineer of PEO licensees working outside Ontario, some Ontario projects are required. If all work has been outside Ontario, provide attestation to this effect.

## CLIENT/CONTACT PERSON:

Entity for whom the project is completed (e.g. RFP issuer, Owner, Project Manager, Person or organization who has engaged your services). This person is not required to be a Professional Engineer.

The contact person should be able to attest to your participation in the project. Indicate the contact's position in the organization as well as a current email address. A contact telephone number is optional. This person cannot be your employer or work colleague at your place of employment.

#### DESCRIPTION OF PROJECT:

Brief outline of project. Project value is not necessary, as this may conflict with client confidentiality. Projects should show variety, depth of experience, and development. Multiple entries for the same type of project may be subject to a personal committee interview for evaluation.

#### MY DUTIES ON PROJECT:

A description of what you actually did on this project. This allows an evaluation of your duties in comparison with the stated duties of a Consulting Engineer and definitions of Consulting Engineering.
